

# Onatru Turns Another Page In Its History

Written by Jane K. Dove, May 2, 2013 Onatru Farm has seen multifaceted use of its 147 acres of fields and woods over the past century.

First a working farm, then a wildlife and nature preserve and later a hub of activity for town sports and events and some of Lewisboro's town offices, the Elmwood Road acreage is about to turn yet another page in its history.

"After a thorough structural renovation, the town is going to offer the refurbished first floor of the main building to residents who want to use it for special occasions and parties,"Town Supervisor Peter Parsons told The Ledger earlier this week. "We are going to kick off this new direction with an art show that will begin on June 28 and run for a week over the Independence Day period and hope the idea of using Onatru for any number of events will catch on."

# **Newly minted farmhouse**

Today, the charming Colonialstyle farmhouse has been restored and rejuvenated and the spacious first floor is ready for use by town residents.

"When we did the renovations, we had two things to consider — making it compliant with the Americans with Disabilities Act and shoring up the entire structure, which had been weakened over the years by the use of the second floor for town offices with heavy filing cabinets," Mr. Parsons said. "The town took advantage of the ADA mandate to put steel beams in the ceilings and steel pillars in the basement. We now have a strong structure that will last us for many years."

Inside on the first floor, the town Maintenance Department, under the direction of Joel Smith, has been working hard over the past months to restore the ground floor to look much as it did in the past.

"Everything has been freshly painted and the original wood floors completely refinished," Mr. Parsons said. "We have also renovated the kitchen to bring it up to standard for caterers."

The main floor of the farmhouse has two large adjacent rooms and an enclosed porch that can accommodate groups. The town has added a new ADA-compliant bathroom. "After we have our grand opening with the art show that begins on June 28, anyone who wants to hold an event at Onatru is very welcome," Mr. Parsons said.

In addition to the newly renovated interior, the Lewisboro Garden Club will be working on the gardens and lawns that surround the main building. The ground is level and can easily accommodate party tents.

"Warm weather events can take good advantage of Onatru's grounds and gardens," Mr. Parsons said. "And parking is more than ample. We believe that this use of Onatru represents a step forward that Alice Lane Poor would approve as part of her vision for the use of her lovely home by the people of our town for happy occasions."

Mr. Parsons said that fees for the use of the Onatru farmhouse and grounds by town residents would be kept affordable.

"We haven't set a fee schedule yet but will do so soon," he said. "Any inquiries about fees, dates and bookings can be directed to our town clerk at 914-763-3511."

# INTRODUCTION

To comply with State regulations, the Goldens Bridge Community Association, Inc. (GBCA) Water System annually issues a report (ADWQR) describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all state drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard. This ADWQR provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

If you have any questions about this report or concerning your drinking water, please contact Ron Arnstein, Water Operator and Chairman of the Water Committee, 914-232-8260. We want you to be informed about your drinking water. If you want to learn more, please attend any of the meetings of the Water Committee. Information as to when meetings are held can be obtained from any member of the Water Committee. These include, in addition to Ron Arnstein, Drew Orr 914-232-9684 and Dan Fast 914-232-5397. Ron Arnstein is available to discuss any drinking water issues with you in person.

### WHERE DOES OUR WATER COME FROM?

In general the sources of drinking water (both tap water and bottle water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves approximately 250 people through approximately 65 service connections. Our water source is groundwater drawn from two wells drilled to depths in excess of 800 feet. The water is chlorinated prior to distribution by the injection of sodium hypochlorite at a level sufficient to maintain a chlorine residual at the furthest point in the distribution system from the pumping and distribution station.

# SOURCEWATER SUSCEPTIBILITY TO CONTAMINANTS

The New York State Department of Health (NYSDOH) has completed a source water assessment for this system, based on available information. Possible and actual threats to this drinking water source were evaluated. The state source water assessment includes a susceptibility rating based upon the risk posed by each potential source of contamination and how easily contaminants can move through the subsurface to the wells. The susceptibility rating is an estimate of the potential for contamination of the source water; it does not mean that the water delivered to consumers is, or will become, contaminated. The presence of contaminants does not necessarily indicate that the water poses of health risk. See section "Are there contaminants in our drinking water?" for a list of the contaminants that have been detected. The source water assessments provide resource managers with additional information for protecting source water into the future.

As mentioned before, our water is derived from two (2) drilled wells. The source water assessment has rated these wells as having a medium-high susceptibility to microbial, industrial solvents and other industrial contaminants. These ratings are due primarily to the close proximity of permitted discharge facilities (industrial/commercial facilities that discharge wastewater into the environment and are regulated by the state and/or federal government) to the wells and the associated industrial activity in the assessment area. In addition, one of our wells draws from an unconfined aquifer of unknown hydraulic conductivity and the other well draws from fractured bedrock and a lower permeability layer exists above the aquifer. Therefore diligent source protection measures are prudent. Please note that, while the source water assessment rates our wells as being susceptible to microbial, our water is disinfected to ensure that the finished water delivered into your home meets the New York State drinking water standards for microbial contamination.

County and State Health Department will use this information to direct future source water protection. These may include water quality monitoring, resource management, planning and education programs.

A copy of the source water assessment has been filed with the Board of Directors of GBCA and another copy can be reviewed by contacting Ron Arnstein. There is currently an ongoing source water contamination review consisting of inspection of the well environs for contamination sources, including septic tank failures, leakage of liquids from automotive vehicles and improper disposal of contaminants.

# ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water. It should be noted that all drinking water, including bottled drinking water may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline (1-800-426-4791) or the Westchester County Health Department at 914-813-5000.

While these tests include an overwhelming number of elements and compounds, we only report those that are actually detected even though they are below the maximum contamination levels (MCL) as specified by the NYState Health Department. The following table shows all detectable "Contaminants" in our drinking water:

#### **DEFINITIONS:**

MCL: Highest level of a contaminant that is allowed in drinking water.

AL: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Milligrams per liter – Mg/L correspond to one part of liquid in one million parts (parts per million – PPM)

Micrograms per Liter – ug/L corresponds to one part liquid in one billion parts of liquid. (parts per billion – PPB)

As you can see by the table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below current federal drinking water requirements.

### WHAT DOES THIS INFORMATION MEAN?

During 2011, our system had no violations as to water quality. Because of the sensitivity of testing methods, some contaminants are usually detected; however, these contaminants were detected below the level allowed by the State.

There was no detectable level of lead, however;

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. Its possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. Goldens Bridge Community Association PWS is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline (1-800-426-4791) or at http://www.epa.gov/safewater/lead.

# IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During 2011 extensive sampling was done and the sampling showed that the drinking water was in compliance with applicable drinking water requirements.

# DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (1-800-426-4791).

#### WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life:
- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions to that essential fire fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- 1. Automatic dishwaters use 15 gallons for every cycle, regardless of how many dishes are loaded. So get a run for your money and load it to capacity.
- 2. Turn off the tap when brushing your teeth.
- 3. Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it up and you can save almost 6,000 gallons per year.
- 4. Check your toilets for leaks by putting a few drops of food coloring in the in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.

### **CLOSING**

Thank you for allowing us to continue to provide your family with quality drinking water. In order to maintain a safe and dependable water supply we sometimes need to make improvements that will benefit all of our customers. The costs of these improvements may be reflected in the rate structure. Rate adjustments may be necessary in order to address these improvements. We ask that all our customers help us protect our water sources, which are the heart of our community.

# BOARD & MEMBERSHIP MINUTES

#### Special/Regular Membership meeting minutes: December 23, 2012

The meeting was convened at 11:15 AM.

Present: 25 Voting Members and approximately 8 other community members.

1-Reading of Minutes:

The minutes from the October 28, 2012 Membership meeting were read and accepted as read. The reading of Board meeting minutes was waived as they will appear on the GoldensBridge.org website, and in Road 4.

2-Ron described the reason for calling this Special Membership meeting, and stated that, since it is often difficult to get a quorum at the regular end of January Membership meeting, and since this meeting was occurring so close to that time, we would handle regular business, as well as special business, at this meeting.

Ron then described the Board of Health requirement that we immediately commence the installation of an emergency generator for the water system, with the threat of heavy fines if we do not comply. He estimated that it will cost up to \$17,000 to install the complete system: 20 kilowatt generator, 500 gallon propane tank, electric transfer panel, all associated wiring and gas lines, and all permitting costs. Discussion by the membership ensued. Dan Fast moved, seconded by Martha Levitus: Due to Board of Health requirements that we immediately install an emergency generator for the water system, we authorize the emergency expenditure of up to \$17,000 for the purchase and installation of a propane fired 20 kilowatt standby generator, 500 gallon filled propane tank, all associated equipment required to provide a complete automated system, and all required permits, with the monies to be taken from the Water Capitol fund. All in favor except one opposed. Motion carried.

3-Financial:

Paul Stewart-Stand, Treasurer, stated that our financial condition is good, with more money in the operating account than was expected. We have a shortfall of approximately \$6,000 from 2012, and will have the same shortfall in 2013 due to an error in the Finance committee's error in not budgeting for the daily testing of the water system. This was previously done for free by Ron, but is now being handled as a part of system maintenance. The money will be taken out of the Water Capitol account, with the replacement dealt with in next year's (2014) budget.

We presently have \$14,592 outstanding for this year from members who have not paid, or are on payment plans, and another \$11,435 outstanding from prior years.

The Rios property is going to auction; the Decaudin situation is complex; the Finance committee is discussing the updating of liens against non-payers

4-Committee reports:

Rental & Sales: A contract for the Mcfadden house for \$155,000, was received. The Board will evaluate.

Beach: Mera Eisen requested volunteers for the Beach committee. A meeting will be held in January

Roads: Fred Margolies stated that community members who have road problems that impact them directly could call the Highway Department directly to request help. The roads are poor in many places. Fred is trying to get the Town Highway Dept. to work on these areas. Meeting adjourned, at 12:20 PM.
