- 2.<u>Lake</u> The graduate student proposal was discussed but there was little enthusiasm for a lake maintenance program for a lake already maintained in good condition. The cost to the community for a two year study would be \$5,000. and would require Membership approval. This was separate from the forebay and suctioning around the swimming area projects.
- 3.Barn/Camp The erosion problem with runoff down the path to the ball field was corrected. There was a difficult situation with a camper that was handled in an exemplary manner by the

Camp Committee and Camp Staff. Martha raised a serious parking problem with parents dropping off and picking up their kids. There are large cars blocking Main Street and Hall Avenue creating an unsafe situation for the Community and there is also a speeding problem. Clearly, we need more parking spaces and cars must be diverted to them. The camp will try to find these spaces.

4. <u>Commemoration Week</u>

A full program is under development by Judy and Martha with many events under consideration for the August 11⁻16 week. This will be publicized when complete and a visual record is planned.
